## Wilentz 1L Diversity/Summer Intern Program Expands to Welcome Six Law Students

In its second year, the Wilentz 1L Diversity/Summer Intern Program has doubled in size. The participants were recruited from Rutgers Law School in Newark, Seton Hall University School of Law, and Fordham University School of Law.

“Wilentz continues to strive to better serve the interests of our clients and advance diversity in the legal profession. The 10-week program is a pivotal immersive work experience for underrepresented law students, and expands our commitment to diversity and inclusion by providing future attorneys with opportunities and mentorship.” said Everett M. The summer program offers an opportunity for qualifying diverse law students, first-generation college graduates attending law school, and law students from economically disadvantaged backgrounds to experience working at a major New Jersey law firm. As part of the program, each 1L student will work on a wide range of matters with lawyers at every level, and gain hands-on, real-world experience. With both shareholder and associate mentors, participants will have the guidance and support needed to learn and grow.
