Our experience in electric, gas, solar, and other renewable energy facilities, pipeline and power plant siting and permitting, telecommunications, water, solid waste, resource recovery, and landfill matters allows us to navigate through the complicated regulatory framework, bringing creative analyses and new approaches to an evolving environment.

### Representative Matters

- Represented a major electric and gas utility in connection with its rate unbundling, stranded costs, and restructuring filings before the New Jersey Board of Public Utilities, its related petition for a bondable stranded costs rate order, and the subsequent resolution of those cases by a stipulation of settlement that was adopted by the Board. A Wilentz litigation team led by John Hoffman successfully defended

that settlement in the Superior Court of New Jersey, Appellate Division, and subsequently in the Supreme Court of New Jersey, where the settlement was upheld.

- Represented major utilities as special counsel in connection with various rate proceedings: prepared witnesses; cross-examined adverse witnesses; briefed rate of return, taxes, accounting, and related matters; and various accounting and rate design issues in connection with appeal.
